- raising employees' environmental awareness, and undertaking initiatives aimed at their participation in environmentally-friendly activities
- providing stakeholders with information on the company's environmental activities
- encouraging consumers to make informed choices that have a positive impact on the environment

IN PREVIOUS YEARS, WE HAVE IMPLEMENTED ENVIRONMENTALLY-FRIENDLY ACTIVITIES WITH MORE THAN 30 ENTITIES

Over **30%** of the country is covered with forests The State Forests manage 76.9% of Poland's forests with a total area of over 7.1 million ha From any location in Poland, one can reach a forest in less than an hour

Approximately 65% of all plant and animal species living in Poland are found in forests

500 million trees are planted annually by Polish foresters

An average of **3.5 million** people per year participate in our educational projects

LET'S AFFOREST POLAND TOGETHER

The main form of cooperation in environmental measures involves the possibility of financial support for the purchase of land to be afforested. Such projects increase the area of forests in Poland. Another option is to support the purchase of private forests to enable sustainable forest management in their area.

ACTIVITY EXAMPLES:

- we have afforested 1 ha of land in the Mieszkowice Forest District in cooperation with the company Sprout World
- we have also afforested over 3 ha of land in the Rajgród Forest District in cooperation with Kingfisher











LET'S PROTECT ANIMALS AND HABITATS

The State Forests run numerous programmes to protect native flora and fauna, which provide support for e.g.:

- M the protection of naturally valuable habitats including petlands and wetlands
- 6 forest animal rehabilitation centres
- 6 forest botanical gardens
- breeding centres for e.g. the western capercaillie, black grouse, grey partridge, and hare
- the protection of certain animal species including the European bison, osprey, peregrine falcon, European pond turtle, and others
- pollinating insects in forests (flower meadows, insect hotels, bee parks, planting melliferous (honeybearing) plants

ACTIVITY EXAMPLES:

- renaturalisation of wetlands in the Przemków and Spychowo Forest Districts, carried out with the company Transition Technologies MS
- the protection of crane habitats through the regeneration of wetland habitats in the Starogard Forest District in coopoeration with PLL LOT

LET'S SUPPORT ENVIRONMENTAL, INFRASTRUCTURAL, AND EDUCATIONAL MEASURES



Construction and upgrading of:

- m tourist trails
- vantage points
- camping sited
 educational facilities
- of forest car parks



Protection of forests from fires:

- equipment
- maintenance of fire escape routes and water take-off points
- improvement of infrastructure e.g. fire observation towers



Nature and biodiversity conservation:

- ☞ support for the State Forests' nature projects
- reforestation carried out as part of standard forest management tasks

ACTIVITY EXAMPLES:

- construction of a wooden observation tower in the Goleniowska Primeval Forest in the Kliniska Forest District, in cooperation with Budimex S.A.
- joint reforestation carried out with the company Teva Pharmaceuticals e.g. in the Bełchatów, Brzeziny, Jabłonna, and Żednia Forest Districts

SELECT A PROJECT (suggest / ask about options)

IMPLEMENTATION OF COOPERATION

Directly with a selected State Forests unit (under an appropriate agreement)

By purchasing Carbon Dioxide Units (Jednostka Dwutlenku Węgla, JDW*), followed by transferring the equivalent of the JDW purchase amount for a selected purpose (under an agreement with the General Directorate of the State Forests)

* A Carbon Dioxide Unit represents 1 tonne of CO₂ that will be accumulated in tree stands and in the soil as a result of the implementation of additional measures. These Units are generated as part of the project Forest Carbon Farms. The price of a Carbon Dioxide Unit is determined based on the primary market auction prices at the European Energy Exchange (EEX) in Leipzig, Germany, and accounts for 10% of its (net) value. The Units are sold via the portal www.e-klimat.lasy.gov.pl. Carbon Dioxide Units are purchased on a voluntary basis, and represent an added value in the PR and CSR areas of the purchaser.



HOW MANY TREES WILL WE COLLABORATIVELY PLANT?

If you provide financial support for forest planting, the minimum area to start with is 1 ha on which approx. 6-8 thousand trees will be planted.

WHAT ARE THE COSTS OF PROJECT IMPLEMENTATION?

Each project is subject to consultation on an individual basis, and its costs are determined by a number of components that are discussed at our organisational meetings.

WHEN IS THE COOPERATION IN FOREST PLANTING IMPLEMENTED?

In the Polish climate, trees are planted twice a year, in spring and autumn, when conditions are optimal for seedling growth, and trees take root best.

CAN EMPLOYEES OF OUR COMPANY PLANT A FOREST ON A VOLUNTARY BASIS?

We organise forest planting sessions in cooperation with the public. These sessions have a form of educational activities / workshops, and are not real support for our responsibilities. In order to organise such a meeting, visit the nearest Forest Inspectorate.

WHAT IS THE DIFFERENCE BETWEEN AFFORESTATION AND REFORESTATION?

Afforestation is the establishment of new forests in areas where there were none before, while reforestation is a process of forest restoration on the site of a previously existing forest.

WILL THE PLANTED FOREST BE USED?

The State Forests operate under the Forest Act which sets out e.g. the objectives and principles for the management of state forests. This Act ensures that these forests are managed in accordance with the principles of sustainable development.

WHERE CAN I FIND A LIST OF POTENTIAL PROJECTS TO BE IMPLEMENTED IN COOPERATION WITH THE STATE FORESTS?

There is no official list of measures to be carried out with our partners. Our offer of cooperation is very diverse and adapted to the individual needs and capabilities of the State Forests at any particular time.

WILL I BE PROVIDED WITH A LIST OF SPECIFIC ACTIVITIES TO BE IMPLEMENTED IN COOPERATION WITH THE STATE FORESTS?

The offer of cooperation with the State Forests is diverse, and the implementation of a particular project is determined by the specific needs and capabilities of the State Forests at a particular time. The final decision on the implementation of cooperation depends on the General Directorate of the State Forests which considers the capabilities and interests of both the State Forests and the potential partner.
